Allowable Subject Matter

1. Claims 1-19 are allowed.

Information Disclosure Statement

The information disclosure statement (IDS) submitted on 11/26/2025, 12/04/2025 and 02/10/2025 was filed after the mailing date of the application on 11/20/2025. Reasons of Allowance

2. Kamangar, U.S. Patent Application Publication No. 2022/0076851 (hereinafter Kamangar) discloses content, such as ads or educational information, may be presented to the patient while in queue (see abstract); however Kamangar does not teach retrieving, by the content delivery injection server, an access credential and/or application programming interface (API) token provided by the video conferencing system authorizing delivery of third-party content through a waiting-room graphical interface of the video conferencing system.

Walia et al, U.S. Patent Application Publication No. 2022/0353468 (hereinafter Walia) discloses rather than a meeting host providing content items, the video conference provider 310 may communicate with the content provider 330 to identify potentially relevant content

items for a scheduled meeting (see paragraph 0070); however, Walia does not teach retrieving, by the content delivery injection server, an access credential and/or application programming interface (API) token provided by the video conferencing system authorizing delivery of third-party content through a waiting-room graphical interface of the video conferencing system.

McBride et al, U.S. Patent Application Publication No. 2022/0368855 (hereinafter McBride) discloses room 100 may include a selection of provider content 106 or videos supplied by a provider organization (see paragraph 0020); however, McBride does not teach retrieving, by the content delivery injection server, an access credential and/or application programming interface (API) token provided by the video conferencing system authorizing delivery of third-party content through a waiting-room graphical interface of the video conferencing system.
